REGULATIONS

1. Gray's Creek Marina will be open on April 29, 2019. (operating hours will be posted)
2. Gray's Creek Marina will provide parking for only one vehicle per slip renter.
3. Gray's Creek Marina shall not be liable for claims, for consequential damages, arising out, occasioned by, or attributable to the nature, construction, design, condition or state of, occasioned by, or attributable to the presence on, rental, occupancy or use of Gray's Creek Marina or the space or premises herein leased by the boat owner or by any person visiting same or being therein.
4. The boat owner agrees to move his boat in accordance with Gray's Creek Marina staff instructions and when unattended, authorize marina staff to move the boat at their discretion and at the owner's expense and risk.
5. The boat owner agrees to pay the cost of all damage to Gray's Creek Marina's property and to the property of any of Gray's Creek Marina tenants resulting either directly or indirectly from the boat owner's negligence.
6. The boat owner agrees that he or she will not do, or permit to be done, any act or thing which may void or make avoidable, any insurance upon building or any property or any part thereof, upon Gray's Creek Marina premises, or which may cause an additional premiums to be paid for such insurance.
7. The boat owner agrees that he or she will make or permit any unlawful, improper, noisy or otherwise offensive use of Gray's Creek Marina property and the boat owner further agrees to observe, obey, and be bound by all the rules and regulations made by Gray's Creek Marina from time to time and posted in or about Gray's Creek Marina property.
8. The boat owner agrees that he or she will not assign this agreement or sublet the space rental herein without the written consent of the Raisin Region Conservation Authority.
9. This agreement shall remain in full force and effect for the entire term set out above, unless sooner terminated in accordance with the following instructions:
 - a. The destruction of the mooring facilities by fire, storm or other calamity.
 - b. Any breach of this agreement by the boat owner, including the rules and regulations of Gray's Creek Marina as provided for herein which form part of this agreement.
10. The boat owner agrees that the terms of this agreement shall remain in full force and in effect as long as he or she remains a tenant of the said Gray's Creek Marina, and shall apply to the herein described boat. Rate and or charges shall be subject to change 30 days after notice of such changes have been given to the boat owner.
