Applications received by the above-mentioned deadline will be compiled and seasonal campers will be chosen by randomly drawing a name from those submitted applications. The number of applications (names) drawn will be equivalent to the number of vacancies in the upcoming camping season.

Using the table below, please indicate your preferred choice of lots, in order of preference (up to 5 sites may be selected). A map has been provided for your reference.

## Obtaining a seasonal site

The draw for seasonal camping will be held on the morning of October 31st, 2025.

- 1. Names will be randomly drawn from the pool of submitted applications.
- 2. The first name drawn will be assigned their top-ranked preferred site indicated on their request form.
- 3. For each subsequent name drawn:
  - a. They will be offered their top-ranked preferred site that is still available (if their first choice is already assigned, they will be offered their next preferred site, and so on through their list.
- 4. If the applicant is unsuccessful in obtaining any of their five preferred sites, they will be contacted to select an alternative site within the park.
- 5. The process will continue (drawing names and assigning sites), until all available spots have been filled.

Following the draw for seasonal sites, successful applicants will be notified to confirm their assigned site. New campers will be required to complete the 2026 Seasonal Camping Agreement and submit the first three pages of the agreement, along with a \$450 lot deposit, to our office no later than Friday, **November 7th, 2025**.

If the completed agreement and deposit are not received by the specified deadline, the RRCA will assume the applicant has elected to decline the seasonal site, and the vacancy will be offered to another interested party.
